



CELEBRATING 25 YEARS

In September 2025, Davis House Child Advocacy Center (CAC) proudly celebrated 25 years of serving children and families in Williamson County. Since opening our doors in September of 2000, Davis House has been a safe place where children who have experienced abuse can share their stories, begin to heal, and find justice.

Over the past quarter-century, more than 10,000 children and their families have walked through our doors and received hope, healing, and support. As we honor this milestone, we look back with gratitude for the community members, partners, and donors who have stood with us—and we look forward with determination to continue protecting children and building a safer future for the next generation.

OUR MISSION

Davis House Child Advocacy Center serves as a first responder in cases involving child abuse in Williamson County. By providing critical services such as forensic interviews, trauma-informed therapy, victim advocacy, abuse prevention education, and coordination of the multidisciplinary Child Protective Investigative Team (CPIT), Davis House CAC helps children heal, thrive, and reclaim their futures.

THE CHILD ADVOCACY CENTER MODEL

A Coordinated, Child-Centered Response to Abuse

Davis House Child Advocacy Center follows a nationally recognized, child-centered model that protects children, reduces trauma, and ensures a coordinated response when abuse is suspected. As the first responders in child abuse cases in Williamson County, our involvement begins the moment a report is made. When law enforcement or the Department of Children's Services suspects abuse, Davis House is their first call. A specially trained forensic interviewer meets with the child in a safe, neutral, trauma-informed setting. This interview is designed to minimize the times a child is asked to describe what happened, sparing them from reliving their trauma.

After the interview, the child's case is reviewed on-site by the Child Protective Investigative Team (CPIT), bringing together law enforcement, DCS, the District Attorney's Office, Juvenile Court, and medical and mental health partners. This coordinated response — unlike the fragmented system children face without a CAC — keeps the child at the center of every decision.

Although child advocacy centers are mandated by the State of Tennessee to exist, the state provides only **15%** of the funding needed for Davis House to operate. Similarly, federal grants contribute to a mere **1%** of our annual budget. This means **84%** of the funding required to protect children and support families must come from our community.

Your support ensures that when a child is brave enough to speak, Davis House is here — ready to listen, ready to protect, and ready to help them heal and find justice.

SERVICES

FORENSIC INTERVIEWS

Children under 18 who may have experienced abuse or trauma come to Davis House CAC for a forensic interview — a child-friendly, neutral conversation where trained interviewers gather the child's experience through their own words with minimal trauma. Interviews are recorded to reduce repeated questioning; without a child advocacy center, children could have to share their traumatic experiences over a dozen times.

CHILD & FAMILY ADVOCACY

The Child and Family Advocate (CFA) guides children and their non-offending caregivers through the entire process, connecting them to needed services at Davis House or with community partners. The advocate supports families for as long as needed, even through trial, or until services are no longer desired.

TRAUMA-FOCUSED THERAPY

Davis House offers trauma-focused therapy for children and teens after they have experienced abuse or other traumatic events. Our licensed therapist uses evidence-based, trauma-informed methods to create individualized treatment plans tailored to each child's needs. Therapy continues as long as needed, with ongoing goal reviews, and children may return for additional support at any stage of their adolescence—always free of charge.

CPIT COORDINATION

Davis House facilitates collaboration among the Child Protective Investigative Team (CPIT) - a multidisciplinary team including law enforcement, department of children's services, medical providers, mental health experts, the District Attorney's Office, and Juvenile Court - to ensure a comprehensive, child-centered response to abuse allegations. By uniting these partners, Davis House coordinates investigations, reduces the need for repeated interviews, and connects families with the care and support they need throughout their journey to justice.

PREVENTION & OUTREACH

Davis House focuses on raising awareness and equipping the community with the knowledge and tools to recognize the signs of child abuse and respond appropriately. Through adult and child-based trainings, presentations, and prevention programs, we empower parents, educators, and community members to protect children, take action when concerns arise, and create a safer environment for every child in our community.

A SAFE PLACE TO BE HEARD - AND TO HEAL

At Davis House Child Advocacy Center, every story begins with courage.

Each day, children in our community find the strength to share what has happened to them — and in that moment, their journey toward healing begins.

One of our forensic interviewers recalls a conversation with a teenage girl who had been groomed online by an adult she thought was her boyfriend.

She bravely shared her story and when our interview ended, she looked around at the toys and books meant for much younger children and softly asked, 'Do little kids come here?' When I told her yes, she grew quiet for a moment and whispered, 'I didn't know this

happened to them too.'

In the weeks that followed, the teen and her family returned to Davis House for therapy and advocacy support. They learned about online grooming, trauma, and—most importantly—how to heal together.

Her story is just one of many reminders that healing doesn't happen in a single moment. It's a process that takes time, understanding, and a community that listens.

At Davis House, we walk alongside children and families through every step of that process—providing forensic interviews, trauma-focused therapy, family advocacy, and prevention education. Together, we help transform moments of fear into pathways of hope.

Because when a child is heard, healing begins.

I have served on the board and am a proud supporter of Davis House because this organization is dear to my heart, because of the impact it has on Williamson County children and because of the bravery of those children in sharing the trauma of abuse.

Davis House Child Advocacy Center is a first responder in cases of child abuse. It is the first place that law enforcement officials turn when child abuse is reported, providing forensic interviews, counseling, victim advocacy, abuse prevention education and more. Davis House is the first line of defense in helping victims of child abuse to heal, thrive, and reclaim their futures.

These services are provided free of charge to all families and only serves Williamson County. Davis House oversaw 346 new cases last year. Those 346 children and children in our community from prior years whom we continue to counsel have experienced unimaginable pain and suffering. But thanks to Davis House, they also had a place to heal and to hope.

While these services are free to all residents of our county, only 16 percent of Davis House's operating budget is covered by government funding. That means 84 percent of its funding comes from the community. Simply put, Davis House needs your help to continue to provide these important services.

In the same way we encourage these children to be brave, we adults need to be brave as well. I will be supporting Davis House CAC this holiday season, and I hope you will join me.

Together, we can help healing begin.

The **Becky Porter Conference Room** honors one of the original task force members whose vision helped establish Davis House Child Advocacy Center 25 years ago and serving a role in the child protection field for 20 years.

Representing the Franklin Police Department, Becky Porter played a pivotal role in developing the Child Protective Investigative Team (CPIT) model—an approach that remains central to how Davis House protects children today.

Within these walls, that same collaboration continues. Professionals from Davis House, local law enforcement, the Department of Children's Services, the District Attorney's Office, Juvenile Court, and Our Kids—a specialized medical agency—gather to review cases, share information, and ensure every child receives the coordinated care and justice they deserve.

Becky continues to inspire those who knew her through her compassion, leadership, and unwavering dedication to children. This room stands as a tribute to the values she championed—a place where teamwork, protection, and hope thrive every day.
